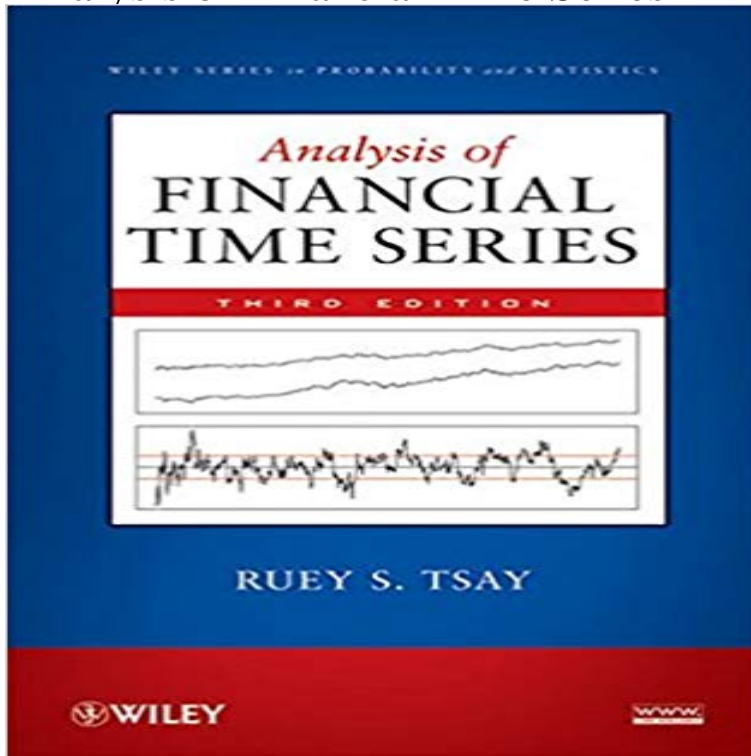


Analysis of Financial Time Series
