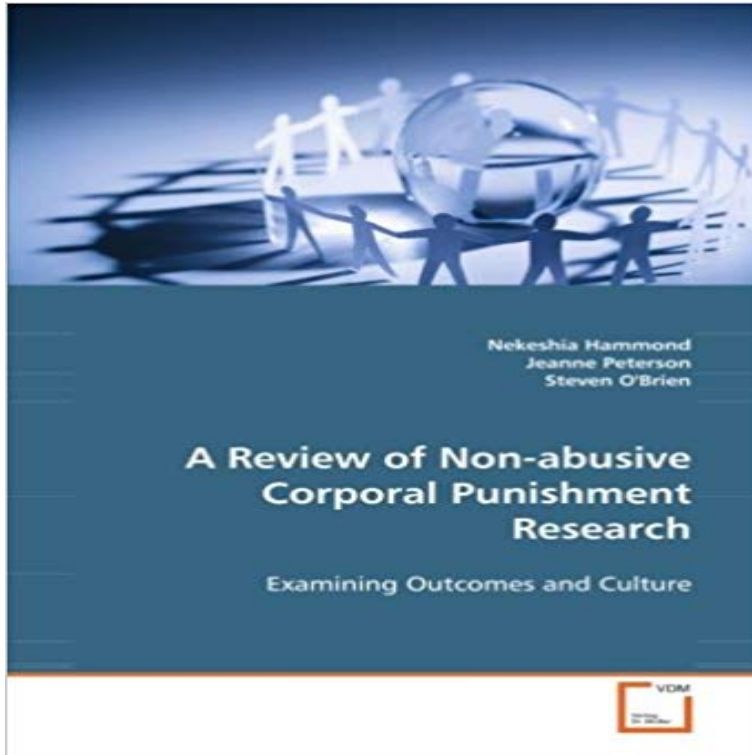


A Review of Non-abusive Corporal Punishment Research: Examining Outcomes and Culture
