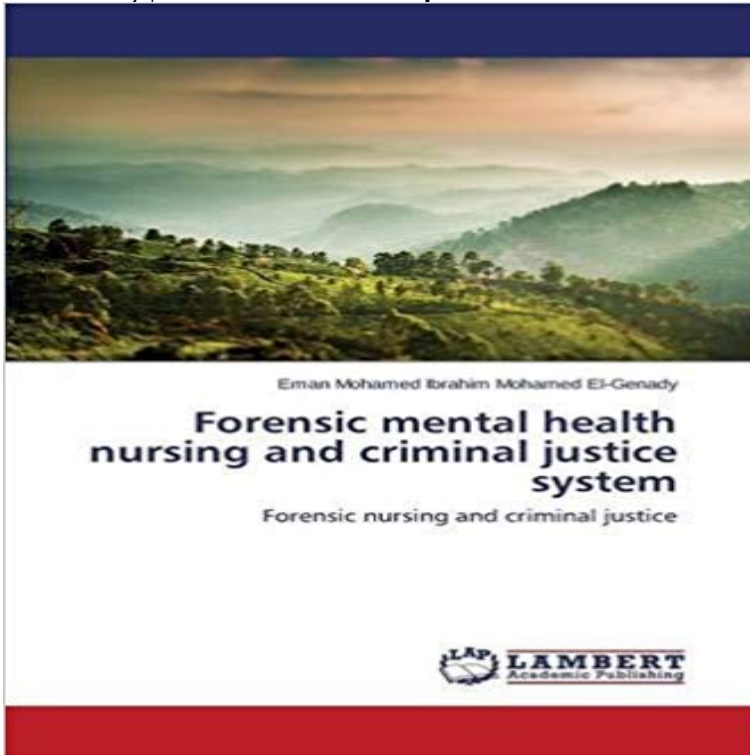


Forensic mental health nursing and criminal justice system: Forensic nursing and criminal justice
