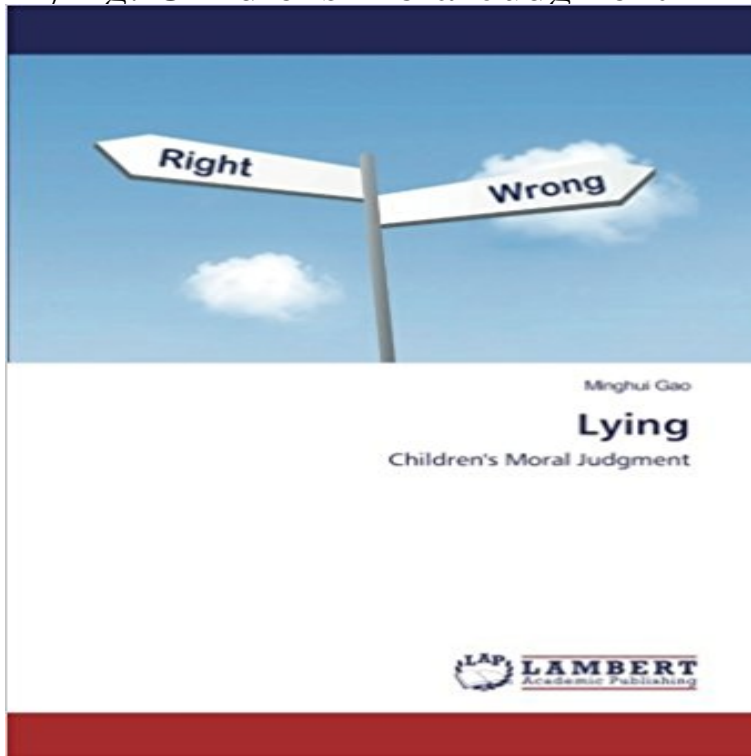


## Lying: Childrens Moral Judgment
