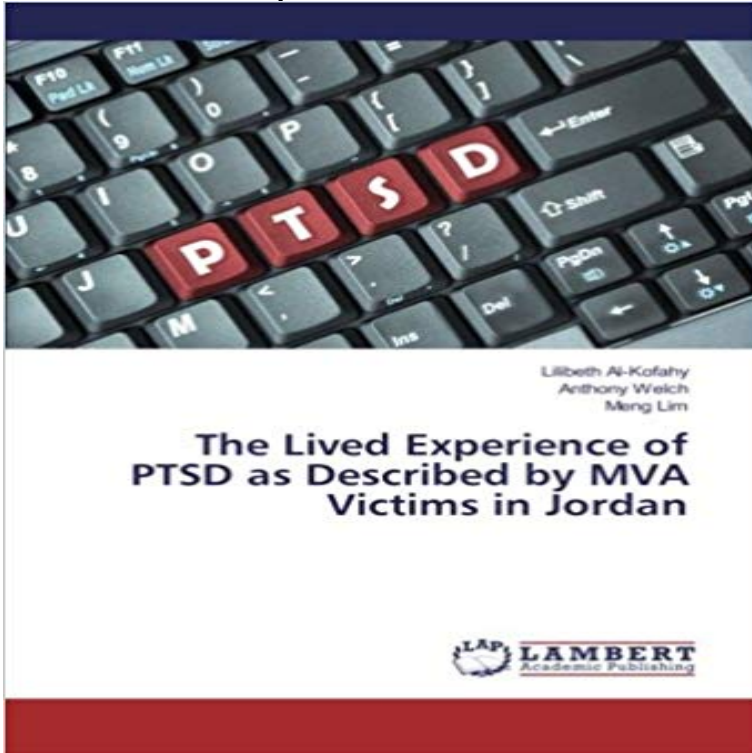


# The Lived Experience of PTSD as Described by MVA Victims in Jordan
